MEETING OPENING / WELCOME

N Troughear welcomed Board members.

Welcome and Karakia

The Meeting was opened by M Williams inviting all present to say the school's karakia. M Williams explained the importance behind the karakia and how it links everyone involved in the school to both each other and to Ōhuirangi.

Deputy Principal Presentation

People and Pedagogy 2022 Update

K Bigwood outlined how the college is building the capacity of the school's middle leaders through the Middle Leadership Programme and how the school is developing the within-school roles of Teaching and Learning Coaches. The Middle Leadership Programme is being shared with local schools and K Bigwood and B Merchant are visiting schools to share best practice. This includes how to develop robust distance and elearning practices.

Teaching and Learning Coaches are being up-skilled to strengthen the parameters around teacher enquiry and K Bigwood confirmed that data is providing key areas of focus for teacher enquiry. N. Troughear raised the question about how enquiry is chosen to choose appropriate topics. K Bigwood confirmed that data had been collected to

support authentic choice. Heads of Faculty are starting to be involved to guide genuine enquiry.

The college is also working more closely to align its teaching and learning practices to Russell Bishop's Teaching to the North-East philosophy which includes working to remove unconscious bias and cultural responsiveness within the classroom to improve outcomes for all.

K Bigwood also shared details about developments within the school for Māori and Pasifika learners, notably the creation of Va'a, a mentoring programme by and for Māori and Pasifika students with an emphasis on more culturally responsive learning to achieve improved outcomes. The programme has been developed and is led by our Head Girls, Charlotte Tukiri and Kayla Ngaropo. There were 18 students who attended the inaugural meeting on 8th August. Board Member A Kefu asked for more information on what percentage of the students who attend were Māori and what percentage were Pasifika students. K Bigwood to find this information and it will be reported back at September's meeting.

Board Presentation

Nicola Troughear, Presiding Member, and Jason Fletcher, Board member, presented their account of the NZSTA 'Journey to Tiriti' that they took part in to the Waitangi Treaty Grounds on 18th and 19th June 2022. The link to the presentation can be found here.

The main points that came out of the journey were how can staff and students work to remove unconscious bias and how does the school move forward in a practical sense and how can the school foster stronger connections with our local lwi to improve connectivity. Face the past, honour the Treaty and move forward together into the future.

PRINCIPAL'S REPORT

The Report was taken as read.

M Williams highlighted the different Principal's associations and their letters to the Ministry of Education to slow down the amount of initiatives being thrown at schools by the government. This is due to the continuing impacts of COVID and the ongoing issues schools are facing with students. In particular, attendance and engagement issues up and down the country are worrying. Pakuranga College is faring well in comparison to many other schools as students remain engaged and attendance is relatively good.

The government has announced initiatives – many of which Pakuranga College is already undertaking as a matter of good practice. The announcement of some \$40 million to improve attendance and engagement has been announced but it is unlikely that Pakuranga College will benefit from any of this as our attendance figures are too good.

M Williams thanked the Board for allowing him to go on sabbatical.

M Williams reported back on his Principal's Sabbatical report and shared how his study and visits to other schools in New Zealand focused on M Fullan's works and ideologies and good to see those in practice in other schools but most encouraging was how forward-thinking Pakuranga College and its staff are.

M Williams acknowledged the great Open Day was on 6th August and said how well it showcased the college. The Board is putting on a full staff morning tea on Friday 12th August to thank the staff for their hard work and commitment.
